### Volunteer Screening/Police Check

For your protection and that of all DayBreak children in our care, we are required to conduct police checks on *all* those volunteering in childcare. This means that we need your permission to request such a check from the Calgary Police Service, if you have not already been screened by Foothills Alliance Church. **Please present two pieces of government-issued I.D. (drivers license, Alberta Health, SIN card or birth certificate).** It will be necessary to complete an authorization form and sign in the presence of a designated church staff member. If you live outside Calgary, a police check should be obtained from the RCMP.
